

DISHWASHER SAFE TEST

The submitted samples were subjected to the following wash cycles and visual examination by naked eye was made in comparison with the control sample.

Wash condition:

Normal Wash: including Wash / Rinse / Main Rinse / Rinse / Rinse / dry steps in each cycle. (Cycle Duration Time: approximately 120 minutes / temperature over 60 °C).

Number of cycle: five (5) cycles.

Detergent: Cascade (75 mL).

Dishwasher: Kenmore

Number of sample tested: _one_(1) piece per style plus _one(1) piece as control sample.

Number of style: _four_(4) styles

Material type: Glass

Rating: Excellent

5) Abrasion which is caused by friction during the dishwasher treatment shall be disregarded.

6) Transparent articles only.

7) Swelling, deformation, cracking or delamination.

8) Corrosion: that includes white deposit on aluminum or rusting on steel materials.

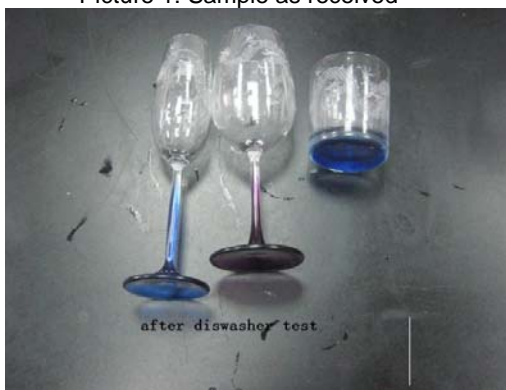
